Presentations will include:

'A Wander round the West Hill Ward of Yesteryear' Malcolm Grimston has a great interest in our local history and will give a talk, with illustrations, on the fascinating history of this area before the 1930s developments which form the bedrock of the SGCARA area.

Neighbourhood Watch Representatives from the local Safer Neighbourhood Team for West Hill Ward will give us valuable updates about Neighbourhood Watch and community safety for our area – may include personnel from Wandsworth Council and/or local police force – tbc.

As usual we have invited our three Ward Councillors and **Rt Hon Justine Greening PC,** currently MP for Putney, Roehampton & Southfields and Secretary of State for Education, and Minister for Women and Equalities.

The formal SGCARA AGM will be part of this meeting, including reports and election of the SGCARA Committee for the coming year.

Planning Matters

Rear-garden land site – West of 17/19 Sutherland Grove/adjoining 2 Combemartin Rd

The developer's Planning Application (PA 2016/1516) for TWO (semi-detached) single-storey dwellings with basements was refused by Wandsworth Council, and their appeal against this decision was turned down by the Planning Inspectorate. There is still Planning Permission (2015/6836) for ONE dwelling (with basement) on that site. There is currently a 'Sold with Planning Permission' sign on the plot, so the future remains uncertain. Work came to a complete halt some time ago on building work for a house, adjacent to 2 Sutherland Grove, again with basement, (2015/6064) suggesting that basement-development is far from straightforward in this area.

Wimbledon Park Road Shopping Parade

Although the original planning applications for change of use/merger of the small shop units in Wimbledon Park Rd were either refused or withdrawn, there is talk that the owner/developer may still seek to merge some units, and create a passageway to land behind the shops on which new flats could be built. We need to remain alert to possible future threats to the existence of the small independent shops that give 'Southfields Village' its charm.

The developer withdrew their Planning Application (PA 2016/6111) for a scheme, including 29 dwellings, up to 7 storeys, proposed for the site. It was clear that the PA was likely to be refused for various valid concerns – including over-development of the site, issues over car-ownership/parking, and lack of clarity about how social housing would be incorporated. The previous permission for a more modest development has now expired. A new PA (2017/2058) has been submitted. The closing date for comments is 25th May on the Council website, (although 18th May on letters distributed.). This new PA reduces the maximum height of the proposed development from 7 storeys to 5, but the number of dwellings would only reduce from 29 to 28, and there is no provision for social/affordable housing, so all the concerns from PA 2016/6111 remain. Poor maintenance of the site was raised with the developer and the demolition of the remaining buildings is finally complete.

Consultations on Heathrow Airport expansion,

All SGCARA homes should have received information about various important public consultations.

The consultation on Night Flights closed on the 28th February.

There are two current consultations 1) on possible Heathrow expansion 2) on 'UK Airspace Policy' including flight-path changes, both of which will affect us greatly. **BOTH CONSULTATIONS CLOSE ON THE 25TH MAY 2017.**

Please take time to consider all the available information about these issues and respond to these consultations.

The present Government appears very much in favour of Heathrow expansion.

Wandsworth Council, (along with Hillingdon Council, Richmond, Windsor and Maidenhead Boroughs, and our current MP Justine Greening) are passionately opposed to the government's plans for Heathrow expansion etc. Department for Transport officials have confirmed to Justine Greening that our current night-time 8-hour flight-respite could be reduced to 4-5 hours if we fail to make our voices heard about this.

Those without internet access can of course read these documents online at Southfields Library, who also have Wandsworth Council's pamphlets and feed-back postcards about these matters.

The document for the previous major consultation on Heathrow Airport expansion was available in hard copy to read at Putney Library. This does not seem to be the case with the current consultations, which is disappointing.

The danger is that Heathrow Airport-expansion etc will take a back seat in people's minds in the run up to the 8th June general election. Make sure that your voice is heard!

Other Local News

Wimbledon Park Masterplan. You may have contributed to Merton Council's consultation in Summer 2016 about their radical plans for Wimbledon Park. About 61% of respondents objected to the Athletics Stadium being moved, and the council have respected this, choosing 'Option 1', ie very much the status quo, but including no change to the siting of the café and Bowling Pavilion. It may include the most popular possibilities from Options 2 & 3, eg the de-silting of the lake, the creation of wetland areas around the lake-shores and a path around it. In December 2016, Merton Council suggested February 2017 for their revised plans in response to the Consultation, but seemingly nothing so far.... Neighbourhood Watch

The good news is that a substantial part of our area is now covered by Neighbourhood Watches. Each Watch Coordinator/Contact notifies those residents on their emailing list with information concerning crimes or attempted crimes on their patch or nearby, and also police initiatives to improve security. (This may include bike marking, security devices available at a discount and so on.) Neighbourhood Watch is separate from SGCARA, although there is some overlap in personnel.

There are currently no Watches in place in Arcadian Place, Artemis Place, Whitefield Close, or in the short section of Augustus Road (together with Chalfont Mews and 1-7 Albert Drive) that falls within SGCARA area.

Being on your Neighbourhood Watch's mailing list will help you to be aware of any current problems. Here are some notes from the West Hill Safer Neighbourhood Panel Meeting 15th March 2017. There will be more helpful information at the Community Safety/Neighbourhood Watch talk at the Members Meeting 15th June.

- West Hill Ward has the second lowest number of reported crimes in the Borough of Wandsworth but even one crime is one too many if it happens to you! In our area there have recently been a number of attempted break-ins, some successful, including cars, sheds, garages, and actual dwellings.
- 722 Pedal Cycles were stolen in Wandsworth in the year to February 2017. Many cycle locks are not good enough – It is recommended that the lock-price should represent about 10% of the value of the bike.
- Sheds should also be secured by an effective lock, and the contents kept securely within them especially if they are bicycles (which should be locked to something 'immovable').
- "Smartwater" is a state of the art product which can be applied to property. Once marked with this solution, regularly-targeted valuables, such as tablets, laptops jewellery, and bikes, can be irrefutably linked back to the owner in the event of a theft and subsequent recovery by the police. It is understood that "Smart Water" has been provided to householders in "The Grid" – with the result that the criminals are turning their attention elsewhere – possibly to those of us in West Hill Ward – beware!!
- If you have a break-in whilst you are at home Phone 999 and if you are unable to speak, wait for the operator and then dial 55. Don't confront the intruders.
- The majority of burglaries are carried out during the day-time when the occupants are out at work etc, allowing the burglars to work un-interrupted.
- Front doors should be made throughout of sound materials which cannot easily be smashed. Keys should be kept securely and out of sight.
- High Hedges Higher Risk ...as they allow the burglar to get on with his 'burgling' unobserved.....
