'As you walk along Girdwood Road you will see the plants in the verges start to emerge. You recall some of these verges were replaced with wildflower turf in 2021. This year the rest were completed by Wandsworth Council's team at **Enable** – the not-for-profit company who undertook the work. You may be interested to know the turf (supplied by **Wildflower Turf Ltd**) comprises thirty two native wildflowers & two non-invasive grasses. The plants are grown on a mesh. In earlier years this mesh was not fully biodegradable but more recently it is. **Wildflower Turf Ltd** have provided wildflower turf for many councils & developments - some prestigious. ('The Hive' at Kew has the same turf as us!) There is a full list of the plants on the



SGCARA website. A quick search of these plants gives a fascinating insight into their stories; some are used in medicine and folklore; all are loved by insects; some have even been found in British fossils tens of thousands of years old. Sharing a small part of our space with them – since many have declined in numbers - seems fitting. I'm looking forward to seeing them emerge!'

Thankyou Annette. Maybe residents will be inspired to have a wildflower turf area in their own gardens?

• Thank you to all residents who completed the Traffic Questionnaire summer /autumn 2023 (offered in Reaching out to Residents summer 2023). Respondents' own experiences showed the severity of the problem, offering

creative possible solutions. (below) photo shows 1 of at least 3 parked cars hit & written off over time by speeding cars One resident made the telling observation:

'It is not an inalienable right to drive into London for your commute (and it is bad for the environment too)'

Where is the vision to persuade commuters to come into London by other ways than driving?

• You will remember the inclusion of the following with the Questionnaire. (received Nov 2021 from a council official with responsibility in this area) 'I would also advise we are due to carry out a comprehensive survey in the local area to help us understand traffic movements which will in turn help develop ideas / restrictions for future consultation.'

• The Report from this 'comprehensive survey' (by external Consultants) was due Aug 2023 SGCARA presumed our own Questionnaire might then feed into its findings & together they would inform action to solve the inter-connected problems of 'rat-running' & excessive speeding.

• A completed Report has still not been released at this point. Following persistent questioning by SGCARA, residents will be shocked to learn it has become clear that at some point the 'comprehensive survey' appears to have been watered down simply to a review of the current Automatic Number-Plate Recognition (ANPR) scheme. This is currently being reviewed by the relevant council Cabinet Member. There are hints that this review may propose making no changes at present. This would be unacceptable.

• The next step is for this issue to be aired at the 22nd April Members Meeting/AGM. Time has been given for our Councillors to update us. Cllr.Grimston has recently been speaking about traffic problems with some residents most affected & will share his ideas. Cllr. Ghossain has offered to raise a formal enquiry with the council into this issue on behalf of SGCARA residents. We will press Cllr.Ireland, (as Cabinet Member for Finance) on allocation of funds to resolve the problems. Our MP Fleur Anderson is not a member of the governing party of course, but may be able to explain some puzzling restrictions on Traffic Calming measures currently imposed by central Govt. These include the reduction of permitted heights for road humps & the halting of pilot schemes to allow Local Authorities to install their own speed cameras & impose speeding penalties.

• Following information gained from our Councillors & MP on the 22nd April, we plan to offer a zoom meeting for residents & to draw up/share template letters

eg to lobby Government to allow Local Authorities (LAs) to have speed-camera pilot schemes.
